E2i SUBSIDY & UTAP FUNDING EXPLAINED

(Funding and subsidies are applicable for the Band Educator's track only)



E2i SUBSIDY

e2i (Employment and Employability Institute) is the empowering network for individuals and companies seeking skills and solutions for growth. Since 2008, e2i has assisted more than 600,000 individuals through our career guidance, professional development, and job matching services. With an extensive network of partners, e2i offers hiring, training and productivity solutions to businesses. They are an initiative of the National Trades Union Congress (NTUC) to support nation-wide manpower and skills upgrading initiatives.

Eligibility Conditions

- 1) Current member of Band Directors' Association (Singapore)
- 2) Member shall be a Singaporean or Permanent Resident
- 3) Member must achieve a minimum of 75% attendance
- 4) Limited slots and therefore on a first come first basis

How to apply?

BDA(S) members will not be required to submit any application. Members will be required to pay an upfront amount of 100% of the course fee first. Members who fulfill the eligibility conditions stated above will then be reimbursed 50% of the course fee at the end of the clinic.

UNION TRAINING ASSISTANCE PROGRAMME (UTAP)

UTAP (Union Training Assistance Programme) is an individual skills upgrading account specially for NTUC members. As a member, you enjoy UTAP funding at 50% of the unfunded course fee capped at \$250 every year.

Eligibility Conditions

- 1) Paid-up union membership before course commencement, throughout whole course duration and at the point of claim
- 2) Course must not be funded through company sponsorship or other types of funding
- 3) Member must achieve a minimum of 75% attendance
- 4) UTAP application must be submitted within 6 months after course completion
- 5) Documents to show the course fee paid by the participant (invoice/receipt)
- 6) Participant certificate of completion

How to apply?

NTUC members will be required to submit their individual claims via the U-Portal at www.ntuc.org.sg at the end of the course. Step by step guide on the claim process is also available on www.ntuc.org.sg. For further enquiries on UTAP matters, please call 6213 8008 or email: utap@e2i.com.sg.

F.A.Q

Q: Can the e2i subsidy and UTAP funding be implemented concurrently?

A: Yes.

For e.g.

Course fee: \$200

E2i subsidises 50%: \$200x 50% = \$100

UTAP funds 50% of remaining unfunded course fees: \$100x50% = \$50

After subsidies (You Pay): \$50

Q: What documents do I need to submit for the UTAP claim?

A: It will be useful to get ready your course certificate and invoice of payment during submission of your claims via the U-portal at www.ntuc.org.sg.
